ANCILLARY WORKS ON RUBAVU-GISIZA ROAD

1. The Government of Rwanda has obtained a loan and grant from the African Development Fund (ADF) to help financing the cost of Multinational (Burundi/Rwanda) Road project (MUGINA-MABANDA--NYANZA LAC and RUBAVU-GISIZA) and trade facilitation on NORTH-SOUTH CORRIDOR, PHASE III. It is expected that part of the amount granted under these loan & grant will be used to make the payments provided under the component of Ancillary Works on RUBAVU-GISIZA ROAD. All bidders, meeting the criteria of origin as defined in the African Development Bank Group Rules of Procedure for the procurement of goods and works, are allowed to compete.
2. Rwanda Transport Development Agency (RTDA) hereby invites international eligible and qualified bidders to submit bids for the execution of Ancillary Works on RUBAVU-GISIZA ROAD (indivisible lot) as follows:
 - Sub-lot 1: CONSTRUCTION OF BRASSERIE - NKORA ROAD (27 km) UNPAVED ROAD,
 - Sub-lot 2: CONSTRUCTION OF KAZABE - RUTSIRO - GASHUBI UNPAVED ROAD (55.33 KM),
 - Sub-lot 3: CONSTRUCTION OF NKORA PORTS, and
 - Sub-lot 4: CONSTRUCTION OF SCHOOL FENCES AND SMALL MARKETS

Deforestation, clearing and stripping; Earthworks in excavation and embankment and cleaning; Rehabilitation of a road 7 m wide unpaved road; cleaning and refurbishment of culverts and construction of new hydraulic reinforced concrete structures and box culvert types; longitudinal ditch by building earthen masonry drains, drainage in embankment, road shoulders with masonry drainage ditch, downspout and crest ditches; Rehabilitation of reinforced concrete structure; construction of retaining walls and gabions; management of intersections and crossings of cities by making tracks and parking areas, sidewalks, crosswalks; horizontal and vertical signaling and safety devices; and construction of port and its other related Facilities.

The Bidding Documents may be obtained at the office of RTDA at the address above from 27th December 2016 upon payment of a nonrefundable fee of twenty five thousand Rwandan Francs (25,000 FRW) or its equivalent in a freely convertible currency on the account N ° 120.00.46 opened at National Bank of Rwanda. Interested bidders may obtain further information and inspect the bidding documents at the above address of RTDA.
6. The provisions of the Instructions to Bidders and those of the General Conditions of Contract are the Clauses of the Standard Bidding Document for Procurement of Small Works issued by the African Development Bank. .
7. All offers must be submitted to the above address not later than 10th February 2017 at 10:00 a.m, local time (8:00 GMT) and be accompanied by a bid security (in the form of bank guarantee) in the amount of One Hundred Million Rwanda Francs (100,000,000 RWF) or against its equivalent in a freely convertible currency.
8. Bids will be opened in the presence of Bidders' representatives who choose to attend at the on the same day at 10:30 a.m, local time (8:30 GMT).
9. The bids will remain valid for a period of one hundred twenty (120) days from the deadline for submission of bids.
10. As an indication, the execution period is estimated to ten (10) months. A recommended site visit (non-mandatory), followed by a pre-bid meeting will be organized by Rwanda Transport Development Agency and the departure is at Rubavu District at eleven (11) o'clock, local time (9:00 GMT) on 10th and 11th January 2017.
