1. The RWANDA TRANSPORT DEVELOPMENT AGENCY (RTDA) funded by ROAD MAINTENANCE FUND (RMF) towards the cost of three years periodic maintenance of paved road. The Client intends to apply a portion of the funds to eligible payments under the tender for Execution works for three years periodic maintenance of Muhanga - Ngororero - Mukamira Asphalt Road (111 Km) .
2. The RWANDA TRANSPORT DEVELOPMENT AGENCY (RTDA) now invites, by the present invitation to tender, sealed bids from eligible and qualified bidders for Execution works for three years periodic maintenance of Muhanga - Ngororero - Mukamira Asphalt Road (111 Km). The execution period is *one year renewable up to three years upon satisfactory performance and funds availability* as indicated in detail in the statement of Requirements.
3. Bidding will be conducted through Open Competitive Bidding and is open to all eligible bidders as defined in the Bidding Documents.
4. Qualifications requirements include those set out in the Tender Document. A margin of preference for eligible national bidders/joint ventures shall not be applied.
5. Tender Documents in *English* may be obtained from *Rwanda Transport Development Agency (RTDA), African Union Boulevard, Former Office of Auditor General, in the*

Procurement Office upon presentation of proof of payment of a non-refundable fee of *Twenty Thousand Rwanda Francs (20,000Rwf)* to Non-Fiscal revenue account of Rwanda Revenue Authority (RRA) at any commercial bank of your choice.

6. Tender Documents may be obtained on any working day from *Friday 27th November 2015 at 07:30AM (05:30am GMT)*.
7. All bids *shall* be accompanied by a Bid Security of *Fifty Eight Million Eight Hundred Thirty Thousand Rwanda francs (58,830,000Rwf)* or an equivalent amount in a freely convertible currency, issued by a reputable bank only.

9. A site visit is scheduled on **Thursday 17th December 2015** and will be conducted by RTDA representative. All prospective bidders are advised to participate. The venue for departure is fixed at **09:00am** local time (07:00a.m GMT) at RTDA Head Office.
10. Well printed bids written in English or French language, properly bound and presented in four copies of which, an original and three copies must reach, in sealed envelopes, to the address below not later than **Tuesday 12th January 2016 at 10:00am local time (08:00am GMT)**. Late bids will be rejected and returned unopened.
11. Bids will be opened in the presence of bidders or their representatives who choose to attend at the address mentioned above on the same day (**12/01/2016**) at **10:30am local time (08:30am GMT)** in RTDA's conference room.
12. The Outer envelope should clearly indicate the tender name and title.
13. The bids should be valid **One Hundred Twenty (120) calendar days** minimum from the date of bids opening.
14. Bidding will be conducted in accordance with the Law N° 12/2007 of 27/03/2007 on Public Procurement as modified and completed to date.
