**TRANSPORT SECTOR SUPPORT PROJECT: SUPERVISION OF THE
UPGRADING WORKS OF BASE-RUKOMO-NYAGATARE ROAD PHASE 2:
NYAGATARE-RUKOMO (73.3KM).**

The Government of the Republic of Rwanda (GoR) has applied for financing from the Saudi Fund for Development (SFD), Kuwait Fund for Arab Economic Development (KFAED), OPEC Fund for International Development (OFID), Arab Bank for Economic Development in Africa (BADEA) towards the cost of upgrading works of Nyagatare – Rukomo road (73.3km) and intends to apply part of the agreed amount for the loan to payments under the contract for consultancy services for the supervision of upgrading works of Nyagatare-Rukomo road 73.3km.

The consulting services include:

- i, The review of the engineering design, preparation of the tender documents and participation in Bid evaluation,
 - ii, The supervision of execution of the upgrading works of the road Nyagatare-Rukomo (73.3km) to full pavement of seven (7) meters width of carriageway (with addition parking lane inside the towns), and 1.5 meters shoulder from both sides (to be changed to 2.0 meters side walk in towns), as well as improvement of the horizontal and vertical design criteria of the road alignment.
- The duration of the supervision consultancy services is 37 Months for which 7 Months is for review of the engineering design, preparation of tender document and participation to the bids evaluation and 30 months for supervision of works.

- The short listing criteria will focus on: Profile of the Firm/Core business and company's establishment, the firm's eligibility documents, experience (must be at least 10 years) in the field, description of similar assignments, summary of qualification and experience of the key staff, annual turnover of the firm in the last 5 years.
- Each firm will need to submit the documents (soft copy (pdf) & hard copy); the soft copy will be sent (1) day before the deadline to procurement office e-mail procurement@rtda.gov.rw and hard copy shall also be submitted to the address below before the deadline indicated below, in case of contradiction between the soft copy and hard copy, the hard copy shall prevail.
- The Rwanda Transport development Agency (RTDA) now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, and availability of appropriate skills among staff, etc). Foreign consultants are invited to form joint ventures with local firms registered in the Rwanda Engineering Council.
- A consultant will be selected through the quality based selection (QBS) method, the short-list and the selection procedure shall be in accordance with the Arab/African associated firms, Saudi Fund, BADEA procedures and in coordination with the Government of Rwanda.


