The Government of Rwanda (GOR) has received a grant from the International Development Association (IDA), acting as an Administrator of the Rwanda Feeder Road Development Multi-Donor Trust Fund (MDTF), and intends to apply part of the proceeds toward payments under the contracts for the Design, Rehabilitation, Upgrading and Multi-Year Maintenance Works of Selected Feeder Roads in Rutsiro District, 41.5 Km.
2. *Rutsiro District* now invites sealed bids from eligible bidders for the **Rehabilitation, upgrading and maintenance works of selected feeder roads in Rutsiro District, including about 41.5 Kilometers of sealed road Lot 1 of 41.5 km, located in the District of Rutsiro**, for an implementation period of 4.5 months for design services and 15 months for rehabilitation works (Phase I- Design and Rehabilitation works) and 2.5 years' maintenance works (Phase II).
3. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credit & Grants by World Bank Borrowers (dated January 2011 and revised July 2014), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

The tender Document may be collected at the District Office upon presentation of the bank slip of fee payment.
6. Bids must be delivered to the address below on or before **1st June 2022 at 14:00 hr Local Time at Rutsiro District Headquarters/Procurement office**. Electronic Bidding *will not* be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **1st June 2022 at 14:30 Local Time at Rutsiro District Headquarters/ Main Conference room**.
7. A site visit is planned for **20th April 2022 at 10:00 AM local time**; the meeting point will be at Rutsiro District Head Office and will be guided by representatives of Rutsiro District and RTDA. Bidders are encouraged to attend the site visit. Subsequently, a **Pre-Bid meeting is scheduled the same day** following the site visit.
8. All Bids must be accompanied by a "**Bid-Securing Declaration**," in conformity of the Form of Bid-Securing Declaration, signed in the issued tender document.
