1. The *Rwanda Transport Development Agency (RTDA)* (hereinafter called ‘‘Client’’) funded by the *Road Maintenance Fund (RMF)* towards the cost of Study Services. The Client intends to apply a portion of the funds to eligible payments under the tender for Consultancy services for **Detailed technical Study of Periodic Maintenance works of Road sections DR16, DR96 &NR14 Kaduha-Munyinya-Rugarama-Nyamagabe, Munyinya-Manwali and Mbazi-Miko Unpaved Road (48 Km)**. The client intends to apply a portion of the funds to eligible payment under the contract for which this request for proposals is issued.

2. The *Rwanda Transport Development Agency (RTDA)* now solicits proposals to provide the following consulting services: **Detailed technical Study of Periodic Maintenance works of Road sections DR16, DR96 &NR14 Kaduha-Munyinya-Rugarama-Nyamagabe, Munyinya-Manwali and Mbazi-Miko Unpaved Road (48 Km)**. More details on the services are provided in the Terms of Reference.

3. A Consultant will be selected under a **Quality and Cost Based Selection (QCBS)** and procedures described in the RFP, in accordance with the Law on Public Procurement as modified and completed to date.

refundable fee of **Ten Thousand Rwanda Francs (10,000 Rwf)** or its **equivalent in a freely convertible currency**. The sum is to be deposited at non fiscal revenue account of RRA at any commercial Bank of your choice.

7. Proposals written in French or English, well sealed and presented in 4 copies (one original and three copies) marked "**ORIGINAL**" or "**COPIES**" accordingly must be submitted to the Procurement Unit of RTDA not later than **04th March 2016 at 10h00AM**. Late proposal will be rejected. The technical proposal shall be in an envelope clearly marked "**Technical Proposal**" and the financial proposal in the one marked "**Financial Proposal**". These two envelopes, in turn, shall be placed in an outer envelope bearing the address and information indicated in the Data Sheet.


