The *RWANDA TRANSPORT DEVELOPMENT AGENCY (RTDA)* (hereinafter called "Client") funded by Government of Rwanda towards the cost of supply and Installation of IT equipments. The Client intends to apply a portion of the funds to eligible payments under the contract for which this Bidding Document is issued. This tender is divided into the following lots:

LOT 1: Supply and configure of IT Equipment

LOT 2: Supply and configuration of monitoring & Network Management, applications server and the firewall software

The *Rwanda Transport Development Agency (RTDA)* invites qualified bidders to submit bids for the *Supply and Installation of IT equipments* as indicated in detail in the statement of Requirements.

Bidding will be conducted through an Open Competitive Bidding and is open to all bidders as defined in the Bidding Documents.

address below from **04th February 2016**, on presentation of the bank statement as a proof of payment of a non refundable fee of **Ten Thousand Rwanda Francs (10,000Rwf)** or its **equivalent in a freely convertible currency**. The sum is to be deposited at National Bank of Rwanda (BNR) on the Account N° 120 00 46 of Rwanda Revenue Authority (RRA).

Well printed bids written in English or French language, properly bound and presented in four copies of which, an original and three copies must reach, in sealed envelopes, to the address below not later than **Friday 11th March 2016 at 10:00am**. Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address below on the same day (**11/03/2016**) at **10:30am** in RTDA's Procurement room.

All bids *must* be accompanied by a Bid Security of **Three Hundred Thousand Rwandan Francs (300,000Rwf)** for **Lot1** and **One Hundred twenty Thousand Rwanda Francs (120,000Rwf)** for **Lot 2** or an **equivalent amount in a freely convertible currency**, issued by a reputable bank. The Outer envelope should clearly indicate the tender name and title.

The bids should be valid **One Hundred Twenty (120) calendar days minimum** from the date of bids opening.
