The *Rwanda Transport Development Agency (RTDA)* invites qualified bidders to submit bids for the *Supply and Installation of IT equipments* as indicated in detail in the statement of Requirements.

Bidding will be conducted through an Open Competitive Bidding and is open to all bidders as defined in the Bidding Documents.

A complete set of bidding Documents in English may be obtained by interested bidders at the address below from **10th December 2013**, on presentation of the bank statement as a proof of payment of a non refundable fee of **Ten Thousand Rwanda Francs (10,000Rwf)** or its **equivalent in a freely convertible currency**. The sum is to be deposited at National Bank of Rwanda (BNR) on the Account N° 120 00 46 of Rwanda Revenue Authority (RRA).

Well printed bids written in English or French language, properly bound and presented in four copies of which, an original and three copies must reach, in sealed envelopes, to the address below not later than **Tuesday 10th January 2014 at 10:00am**. Electronic bidding *shall not* be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders' representatives who choose to attend in person at the address below on the same day (**10/01/2014**) at **10:30am** in RTDA's conference room.

All bids *must* be accompanied by a Bid Security of **Five Hundred Thousand Rwandan Francs (500,000Rwf)** or an **equivalent amount in a freely convertible currency**, issued by a reputable bank or a registered insurance company. The bid security shall be issued by a reputable bank or a registered insurance company.

The Outer envelope should clearly indicate the tender name and title.

The bids should be valid **One Hundred Twenty (120) calendar days minimum** from the date of bids opening.
